



## BORROWER CERTIFICATION

2. I have not pleaded guilty to, been found guilty of, nor am I currently incarcerated, on probation, or on parole for a felony conviction or a crime of moral turpitude;
3. I am not currently facing charges for a felony or a crime of moral turpitude and am not currently on probation or parole for any crime;

8. I understand that, if approved, information related to this linked deposit application, such as business name, loan amount, estimated savings, etc. may be released without further notice in the promotion of the MOBUCK\$ linked deposit program;

12. I understand that knowingly making a false statement on my application for a MOBUCK\$ Linked Deposit Program Loan constitutes a **Class A misdemeanor** under Section 575.050, RSMo, and **may be punishable by up to one year of imprisonment**, as outlined in Section 558.011, RSMo.

I agree to notify my lending institution in writing if, at any time during the term of my MOBUCK\$ Linked Deposit Program loan, there is a change in my status with respect to any of the certifications previously provided. Furthermore, I agree to notify my lending institution in writing if I become ineligible to participate in the MOBUCK\$ Linked Deposit Program. Failure to provide such notification within ten (10) business days of the status change will result in the immediate cancellation of my participation in the program and forfeiture of any associated benefits.
